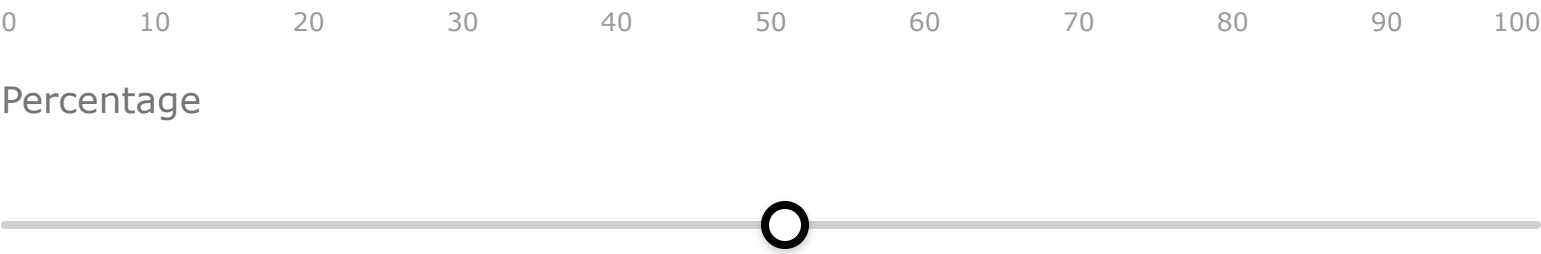

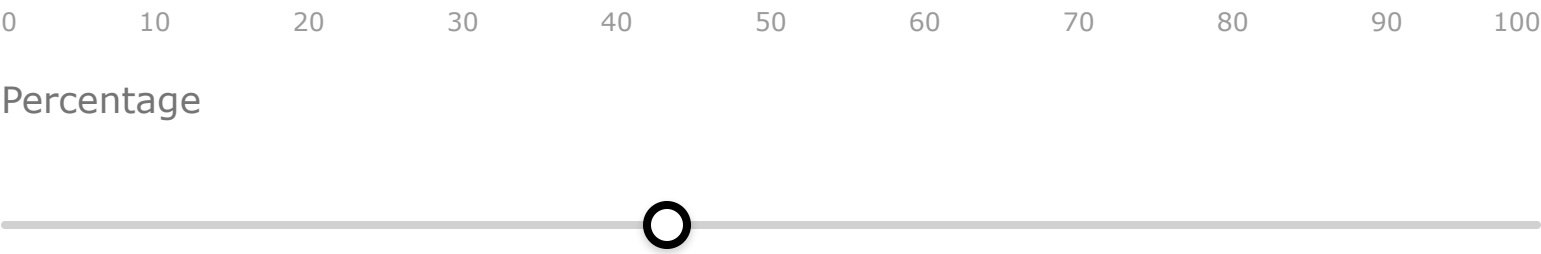

When thinking about barriers and challenges, our program notes that faculty resources are a significant barrier and challenge for the program. There are limited resources for continued development. Additionally, administration does not always understand and/or value the uniqueness of our program. We are able to increase enrollment while not increasing university cost structure, but we are not given those additional resources to our program. Additionally, the cost to maintain CACREP accreditation is quite expensive, and without our university truly understanding our roles, the financial support is often met with resistance.

What successes or available resources have contributed most to your program's growth, effectiveness, or ability to support students?

Aside from obtaining CACREP accreditation, which has increased clinical mental health student interest in our program, the program's faculty and their work to advocate for the program has helped with our success. The university recently added telehealth services to support the mental health of remote students, which provides invaluable support.

What is CACREP doing well for your program that you appreciate?

CACREP accreditation has increased the publicity of our clinical mental health program because they have given our students the ability to apply for jobs that require CACREP-accredited counselors.

What would you like to see CACREP do differently in its current services?

When thinking about what CACREP could improve upon, faculty members in our program have mentioned the desire for CACREP to increase its voice in protecting counselor identity in our state and in others. Our program would like to see CACREP more vocally support the work we do as counselor educators, and our faculty would like to see CACREP fight back against the de-professionalization of our counseling programs. Additionally, CACREP seems to be more educated on clinical mental health and related programs than on school counseling programs. I would like to see CACREP develop a more school counseling friendly standard base, even if this means adding a bit of separation between the programs. For example, our clinical mental health programs have always been 60 hour programs. However, our School Counseling program had to add 12 hours to our program to receive the CACREP accreditation. Because school counseling is not currently tied to CACREP in most states, our enrollment may have actually taken a hit when receiving the accreditation.

What services or resources would you like to see CACREP add or develop that would better serve you and your program?

Our program would like to see CACREP develop or publicize more financial resources for our students, beyond the fellowships, to help our students have additional support to complete their counseling programs. Aside from adding financial assistance, our program would like to see CACREP consult more with their accredited programs. We would like to see a more targeted consulting approach, beyond basic questions added to the end of the yearly report. For example, CACREP decided to add an additional residency requirement for online programs, but online programs were not contacted to provide feedback or to be given a heads up as to changes that may be coming so we could advocate for/against them. It is disappointing that CACREP does not seem to value the invaluable feedback of our programs when making decisions for us.
