Graduates who complete this program will have met the state requirements and will be eligible for the Licensed Professional Counselor (LPC) license or the Licensed Professional Counselor- Mental Health Service Provider (LPC-MSHP) license in Tennessee. This program prepares students for community counseling in settings such as hospitals, health centers, community agencies, and etc. All graduate courses are online. There is a mandatory three-day residency on the UT Martin Campus upon the completion of 15 credit hours.
